Heard Mr. S. Barthakur and Mr. U. B. Sarma, learned counsel for the petitioner. Also heard Mr. C. Baruah, learned counsel for respondent Nos.3, 4 and 5 and Mr. R. K. D. Choudhury, learned Senior Government Advocate for respondent Nos.1 and 2.

Through the order dated 27.08.2018, this Court after having accepted the submission on behalf of the Government of Assam had granted time of one month to place the Rules. The learned Government Advocate has produced a letter issued vide No.ABP.126/201/226 dated 24.09.2018 stating that further time would be required for final decision. The learned Government Advocate further submits that the entire process would be completed if two months time is granted.

Though such request is made, we find that the respondents are required to show some sense of urgency in the instance case. In that view, we are of the opinion that though some time is necessary to be granted, it is also expected that the respondents would complete the process within the date fixed.
