Heard Mr. S. Borthakur, learned counsel for the petitioner. Also heard Mr. R.K. Dev Choudhury, learned Senior Government Advocate, Assam as well as Mr. C. Choudhury, learned standing counsel, APSC, appearing for the respondents.

Mr. Choudhury has submitted that Government has forwarded the Assam Public Service Commission Rules of Procedure, 2017 to the APSC for further necessary action.

It is pointed out by Mr. Baruah that preliminary examination for Assam Civil Service and Allied Services is going to be held on 30.12.2018 on OMR sheet and, therefore, the transparency that is sought to be achieved by Mr. Borthakur in the conduct of the examination, will not really be an issue in the preliminary examination.
