With reference to the subject cited above, I am to inform you that the Commission advertised for the posts of different categories in the Directorate of Forensic Science, Assam and Regional Forensic Laboratory, Jorhat under Home & Political Department on 16.01.2017 vide advertisement No.01/2017.

It may be mentioned here that the said advertisement covered 7(seven) categories/disciplines/divisions comprising 22 posts. But, as the recruitment process got delayed for years together for various reasons and in view of the Hon'ble Gauhati High Court's order passed in the PIL (Suo-Moto) No.35/2016, the Commission conducted interview for the post of Deputy Director, Ballistics Division and Serology Division in the Directorate of Forensic Science, Guwahati and Deputy Director, Ballistics Division in the Regional Forensic Science Laboratory, Jorhat on 5th, 6th & 7th April, 2017 with the help of experts/advisers deputed by the Government.
